7. BACKGROUND: The above referenced properties are currently owned by County Lands and can be made available						
for affordable housing in the Harlem Lakes subdivision. In accordance with the United States Department of Housing						
and Urban Development (HUD) HOME Program, the Department of Human Services (DHS) is required to provide						
15% of the HOME allocation to Community Housing Development Organizations (CHDO's) for the provision of						
affordable housing. Additionally, DHS agreed to provide half of the 15% CHDO set aside for projects located in						
Dunbar as part of the Dunbar Annexation Interlocal Agreement for a period of three years (2003, 2004, and 2005).						
In coordination with the City of Fort Myers, DHS advertised the availability of the CHDO set aside funds and the						
available properties as building locations and requested proposals from qualified organizations. Lee County Housing						
Development Corporation responded and is proposing to build three houses in Harlem Lakes to sell to very-low						
income families for affordable housing. The donation of the lots will offset the cost of construction, making the						
housing more affordable.
