ACCESS EASEMENT GRANT

This Indenture is made this <u>ID</u> day of <u>Feb.</u>, 2004 between, **Gladiolus Preserve Homeowners Association, Inc. a Non-Profit Florida Corporation**, whose address is 11220-27 Metro Parkway, Fort Myers, Florida 33912 and **GLADIOLUS PRESERVE**, **L.L.C.**, a Florida Limited Liability Company, whose address is 11220-27 Metro Parkway, Fort Myers, Florida 33912 (Grantor), and Lee County, a political subdivision of the State of Florida, whose address is Post Office Box 398, Fort Myers, Florida, 33902 (Grantee).

For good and valuable consideration, the receipt of which is hereby acknowledged, Grantor hereby grants to Grantee, its successors and assigns, an access easement for the purpose of providing access over, across and through Grantor's property so that Grantee's employees, agents, consulting engineers, contractors and other representatives' vehicles and equipment may have ingress and egress for construction and maintenance of the stormwater drainage structures and conveyance system for Gladiolus Drive. The easement is situated in Lee County, Florida and more particularly described in attached Exhibit A.

Grantor retains the right to continued use of the property for any and all purposes that do not interfere with Grantee's use of the easement.




