1. The above recitations are true and accurate and are hereby adopted and incorporated herein as if set out at length.

- Lee County recognizes and accepts the donation and transfer of the funds to Lee County.
- 3. Lee County agrees to use the funds for the Fort Myers Public Library.
- 4. In order that the proposed transaction is more efficiently consummated, the Board specifically authorizes and directs the Chairman or Vice Chairman of the Board of County Commissioners to execute any and all necessary documents for the said transaction on behalf of the Board of County Commissioners.
