## 1. <u>REQUESTED MOTION</u>:

**<u>ACTION REQUESTED</u>**: Authorize the Department of Parks and Recreation to expend an amount not to exceed \$400,000 for exotic removal, planting of native vegetation and repairs (includes \$24,000 Land Supervisor fee) to Lakes Park through the Agreement between the Lakes Park Enrichment Foundation, Inc. and Lee County for the implementation of the Master Plan. At this time it is being requested that the Board approve waiving of the formal process (if needed) and authorize the use of the Department of Parks and Recreation to purchase services and materials directly from the Lakes Park Enrichment Foundation as a cost/time saving measure.
