7. BACKGROUND:								
The Letter of intent has been received. The plans have been reviewed for conformance to the Lee County Utilities Operations Manual. This phase of the project includes constructing approximately 7,146 feet of 12" force main; 3,120 feet of 8" force main with all related fittings with the 8" diameter segments of the force main considered temporary to avoid impacting wetlands that are located outside of the existing right-of-way of Corkscrew Road. The second phase of this project will be the replacement and removal of the 8" segments with 12" diameter pipeline prior to the commencement of the Corkscrew Road widening project.
