Attorney's recommendation. Commissioner Atoron stated that the issue is who decrues to apply, and noted that this should be an open process with a legitimate bona fide search. Commissioner Judah noted that he couldn't support the motion with the formal designation, and that depending on the outcome of the original motion he would proffer another motion. Commissioner Albion stated that the motion is to formally designate Robert Gray as interim County Attorney effective upon the moment of retirement by County Attorney Yaeger, until such time as a decision is made and whoever is to replace Attorney Yaeger formally starts their duty. The main motion was called and failed with Commissioners Albion, Janes, and Judah voting nay. Commissioner Judah moved to recognize that the procedure allows for Attorney Gray, as Deputy County Attorney, with Attorney Yaeger's resignation, to provide for oversight and management of the County Attorney's Office and this Commission, seconded by Commissioner Janes. In reply to the perception, Attorney Yaeger stated the motion and the record are clear that Attorney Gray has the authority to sign and act as Deputy County Attorney. The motion was called and carried. After the motion was called and carried: Commissioners Judah, Janes, and Albion congratulated Attorney Gray, and wished him luck in the process.

DURING THE ANNOUNCEMENTS PORTION OF THE MEETING, THE CHAIRMAN ANNOUNCED THAT: Five Walk-On Items would be heard after consideration of the Administrative Agenda. In response to Commissioner Albion's question, Commissioner Judah moved to defer Walk-On Item No. 5 to the August 3 Board meeting to provide more attention and specificity to the item, seconded by Commissioner Coy, called and carried.

COMMISSIONER ITEMS

<u>BID WAIVERS</u> - Commissioner Janes indicated that he was concerned with the excessive number of Bid Waivers being considered, and expressed caution on using this process incorrectly.

SENATORIAL OFFICE - Commissioner Janes noted that, as Legislative liaison, he was contacted by US Senator Bill Nelson's Chief of Staff Pete Mitchell to inform him that Senator Nelson is interested in opening up an office for the citizens of the County and Southwest Florida in Lee County; remarked that Mr. Mitchell inquired whether there was any usable space approximately 525 square feet for the Senator to use as a Senatorial Office; and mentioned that Assistant County Manager Holly Schwartz has been researching with Facilities Management Director Richard Beck. Commissioner Janes suggested that the Board look into all available space, seconded by Commissioner Judah. Ms. Schwartz stated that staff would look into all available space, noted that it has been suggested that staff come forward with a policy on whether or not to charge for the space, and remarked that the County charges for any space in the SunTrust building. County Manager Donald D. Stilwell suggested coming back at the next meeting with a recommendation on this issue, and allow time to have a firm policy. Brief discussion was held between Commissioner Albion and Mr. Stilwell about scheduling this issue for the next Management and Planning (M&P) meeting, and whether the officials requesting the space have a normal budget for these types of
