INTERLOCAL AGREEMENT

This Interlocal Agreement is made and entered into this _____ day of ______, 2004, by and between LEE COUNTY, FLORIDA, a political subdivision of the State of Florida (hereinafter "COUNTY"), and the CITY OF CAPE CORAL, FLORIDA, a Florida municipal corporation located within Lee County (hereinafter "CITY").

WHEREAS, pursuant to the powers and authority granted to the parties hereto under the constitution of the State of Florida and by statute, each has planned, separately and in cooperation with the other, an integrated road network; and

WHEREAS, in a cooperative effort between the parties to accomplish shared transportation objectives, certain interrelated capital transportation facilities known as the "Midpoint Bridge" (from (DeLeon Street in the City of Fort Myers to the Del Prado Interchange in the City of Cape Coral, the "East-West Corridor" [now known as the "Veterans Memorial Parkway"]) from the Del Prado Interchange west to the County Line including Burnt Store Road from Pine Island Road north to the County Line and Colonial Boulevard from DeLeon Street to Solomon Boulevard in the City of Fort Myers) (collectively, the "PROJECT") have been planned and have been or are being constructed; and

WHEREAS the CITY and the COUNTY entered into an Interlocal Agreement regarding their respective duties and responsibilities for the PROJECT; and

WHEREAS, the parties seek to continue their cooperative effort in the construction of an access ramp from Everest Parkway in the CITY to the eastbound lanes of Veterans Memorial Parkway.

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, the parties agree as follows:

1. The Recitals as set forth above are incorporated into the terms of this Agreement as if set out herein at length.

2. CITY agrees to transfer, by Quitclaim deed, the property described as "Parcel C" which is depicted and described in Exhibit "B" which is attached hereto and incorporated herein by reference. Said property will be used by COUNTY for the construction of an access ramp from Everest Parkway in the CITY to the eastbound lanes of Veterans Memorial Parkway.

3. COUNTY will be responsible for the design and construction of the access ramp. COUNTY will use surplus toll revenues to fund the cost of the design and construction of the access ramp, in accordance with the provisions of the March 22, 1995 Lee County/City of Cape Coral East-West Corridor Interlocal Agreement and the subsequent amendments thereto.

4. COUNTY will be responsible for the maintenance of the access ramp.

5. COUNTY agrees that if requested by CITY, COUNTY will grant to CITY an easement, at no cost to CITY, over COUNTY's portion of the vacated canal right-of-way that is adjacent to Lots 13 through 19, and a portion of Lot 20, Block 1203, together with a portion of the Everest Canal right of way vacated by City of Cape Coral Resolution 13-01, dated March 29, 2001 and recorded in O.R. Book 3392 at Page 3101, all within Block 1203, Cape Coral Subdivision, Unit 19, according to Plat Book 13, Pages 121 through 135 of the Public Records of Lee County, Florida, for CITY to use as a stormwater

retention area when CITY constructs a fire station on CITY's property adjacent to and west of the exit ramp.

6. CITY agrees to transfer, by Quitclaim deed, to COUNTY the property described as "Parcel A" which is depicted and described in Exhibit "A" which is attached hereto and incorporated herein by reference. Said property is the property upon which the current exit ramp [extending from the south side of Veteran's Memorial Parkway (east of Del Prado Boulevard) to Everest Parkway] is located.

7. The conveyances by the City referenced in paragraphs 2 and 6 above are expressly subject to the adoption of an ordinance authorizing those conveyances.

8. In the event any one or more of the provisions contained in this Agreement is, for any reason, held invalid, illegal, or unenforceable in any respect, such invalidity or illegality or unenforceability will not affect any other provision hereof, and this Agreement will be construed as if such invalid, illegal or unenforceable provision had never been contained herein.

9. This Agreement may be executed in counterparts, with each Agreement becoming a fully effective and binding document upon the parties once both parties have each executed this Interlocal Agreement by their duly authorized representatives.

IN WITNESS WHEREOF, the parties have hereunto set their hands and seals the date and year first above written.




