## MODIFICATION #1 TO PRE-DISASTER MITIGATION AGREEMENT

This Modification Number One is made and entered into by and between the Florida Department of Community Affairs ("the Department") and Lee County ("the Recipient") to extend the agreement between them dated March 27, 2003 and numbered DCA Contract No. 03DM-58-09-46-01-004 ("the Agreement").

WHEREAS, the Agreement expired June 30, 2004;

WHEREAS, the parties desire to reinstate and extend the Agreement to August 20, 2004 in order for the Recipient to complete the Scope of Work, as set forth in Attachment A; and

NOW, THEREFORE, the parties agree to reinstate, extend and modify the above referenced Agreement as follows:

1. Paragraph (3) of the Agreement is hereby deleted in its entirety, and the following paragraph substituted in its place and stead for all intents and purposes:

This Agreement shall begin March 27, 2003 and shall end August 20, 2004, unless terminated earlier in accordance with the provisions of paragraph (9) of this Agreement.
