POLICY TITLE: PROTEST ARISING FROM THE CONTRACT BIDDING PROCESS

AUTHORITY FOR POLICY: Florida Statute Section 120.57(3), 255.0516

DATE OF ADOPTION BY THE SCHOOL BOARD: November 4, 1982 Revised: December 18, 2003

This rule shall apply to protests relating to any contract entered into by the School Board with a contractor or subcontractor pursuant to the provisions of Part II of Chapter 23, Chapter 255, Chapter 287, or Chapters 334-349 of the Florida Statutes.

Whenever the School Board makes a decision or intends to make a decision concerning a bid solicitation or contract award, the superintendent or his designee shall give notice of the decision or intended decision by United States Mail, by fax or by e-mail to all bidders. Within the notice, the following statement shall appear "Failure to file protest notice within the time prescribed in Section 120.57(3), Florida Statutes, shall constitute a waiver of proceedings under Chapter 120, Florida Statutes."

For any other School Board decision falling within the ambit of this policy, notice of the decision or intended decision shall be given either by posting the bid tabulation at the location where the bids were opened, by sending the notice by United States Mail, by fax or by e-mail to the bidders.

Florida Statute Section 120.57(3) requires that "Any person who is affected adversely by the agency decision or intended decision shall file with the agency a notice of protest in writing within 72 hours after the posting of the bid tabulation or after receipt of the notice of the agency decision or intended decision and shall file a formal protest within 10 days after the date he filed the notice of protest. Failure to file a notice of protest or failure to file a formal written protest shall constitute a waiver of proceedings under Chapter 120."

Whenever a protest is filed, the School Board will require the protestor to post a bond under provisions of Florida Statute Section 255.0516 in the amount of: (1) twenty-five thousand dollars or 2 percent of the lowest accepted bid, whichever is greater, for projects valued over \$500,000; and (2) five percent of the lowest accepted bid for all other projects. Said bond shall be held and used in payment of any costs and fees which may be adjudged against the protestor in the administrative hearing.
