- Whereas: The Child Advocacy Program at the Children's Hospital of Southwest Florida was established in 2003 to provide a proactive approach toward keeping children healthy and safe; and
- Whereas: Drowning is the leading cause of death for Florida children between the ages of 1 and 4 and the majority of these drowning take place in pools and ponds at times when a family is home; and
- Whereas: The Child Advocacy Program has a mission to prevent childhood drowning and near drowning through public awareness, education and outreach by collaboration and coordination of community resources; and
- Whereas: The Child Advocacy Program will launch an "April Pool's Day" water safety awareness campaign promoting active supervision by a parent or guardian whenever children are in, near, or around any type of water including; swimming pools, lakes, streams, beaches bathtubs and buckets of water; and
- Whereas: The April Pool's Day Campaign is a collaborative effort between The Children's Hospital of Southwest Florida, Lee County Health Department, Lee County Coalition of Safe Kids and SWIM Lee.

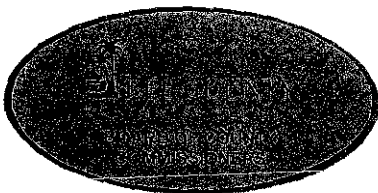
