The Department of Public Safety submitted a request to Contracts Management to obtain p 03 MASS CASUALTY EXERCISES PLAN. The expected cost of this service required the use of the formal Proposal Process. The deadline for receipt of the proposals was May 24, 2005. The Proposal Evaluation Committee consisted of: John Wilson, Chairman, Public Safety, John Campbell, Emergency Management and Robin Bare, Human Resources.

A total of three (3) proposals were received by the established deadline. All three (3) proposals were considered at the Proposal Evaluation Committee meeting held on May 26, 2005. After review of the proposals, the Committee required additional information prior to making their selection. A Clarification Letter was sent to all three (3) firms on May 26, 2005 requesting additional information. The Proposal Evaluation Committee reconvened on June 15, 2005 to evaluate the additional information requested.

Based on the Evaluation Criteria established in the RFP, it was the consensus of the Committee to recommend award to MTSS IT Solutions, Inc.

Funding for this project is provided through a subgrant agreement between the State of Florida, Department of Community Affairs and Lee County (Contract Number 05DS-__-09-46-01-) to perform eligible activities as identified in the Office of Domestic Preparedness (ODP) fiscal year 2004/2005 State Homeland Security Grant Program (SHSGP)".
