9. Background:

On April 26, 2005, Lee County Commissioners approved Change Order No. 5 to APAC-Southeast for \$72,747 for signalization costs at the intersection of Pine Island and US Business 41 with the understanding that FDOT would be funding the project 100% on a reimbursement basis once funds were appropriated from the State Legislature in State Fiscal Year 2006. FDOT has budgeted \$87,368 for the signalization and will allow the County to use the additional funds (\$14,621) for other construction costs associated with the Business 41 project. Budget was originally established within the project for \$72,747 for the signalizations costs and now needs to be increased to recognize the additional \$14,621 that FDOT will be reimbursing the County.

- 1. All expressions used herein, unless herein separately defined, shall have the same meaning herein as in the Agreement.
  - 3. Paragraph 3A of the Agreement is deleted in its entirety and in its place is substituted the following:

"The DEPARTMENT agrees to a maximum participation in the amount of THREE MILLION TWO HUNDRED TWELVE THOUSAND AND THREE HUNDRED SIXTY EIGHT DOLLARS (\$3,212,368.00). The COUNTY agrees to bear all expenses in excess of the DEPARTMENT'S participation."

Except as expressly or by necessary implication modified hereby, all provisions of the Agreement shall remain in full force and effect in accordance with their terms but in the event of any inconsistency(ies) between the provisions of the Agreement and the provisions hereof, the latter shall prevail.
