9. Background:

Letters of Interest were solicited on behalf of the Board of County Commissioners for professional services for the Corridor Alignment Study for Luckett Road and Sunshine Boulevard.

The deadline for receipt of Letters of Interest was January 12, 2006. A total of eight (8) Letters of Interest were submitted by the established deadline. All eight (8) Letters of Interest were considered at the Competitive Negotiations Committee on January 18, 2006. The Competitive Negotiations Committee consisted of Scott Gilbertson, Director, Lee County DOT (appointed by Jim Lavender), Don DeBerry, Lee County DOT, and Sarah Clarke, Lee County DOT, Project Manager. Based on the information submitted by all eight (8) firms, it was the consensus of the Committee to invite three (3) firms for written and oral presentations.

On the basis of the information submitted by the firms in the Letters of Interest and after conducting oral presentations on January 31, 2006, the Committee agreed to recommend to the Board the following order of ranking of Consultants: (1) Inwood Consulting Engineers; (2) McMahon and Associates, Inc.; and (3) URS Southern Corporation.

The negotiated Agreement will be brought back to the Board for approval.
