9. Background: Letters of Interest were solicited on behalf of the Division of Solid Waste for professional services for the Lee County Household Chemical Waste Facility project.

The deadline for receipt of Letters of Interest was June 5, 2006. A total of five (5) Letters of Interest were submitted by the established deadline. All five (5) Letters of Interest were considered at the Competitive Negotiations Committee meeting on June 9, 2006.
