## 9. Background:

Plantation Road Extension Project 4065, will be constructed from the intersection of Colonial Boulevard with Veronica S. Shoemaker Boulevard, south to Plantation Road and consists of a four-lane divided highway, with sidewalks, stormwater drainage, and utilities. Approval of the Resolution of Necessity is required should condemnation proceedings be necessary for the acquisition of parcels required for the project.

## RESOLUTION OF NECESSITY OF THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA

WHEREAS, after consideration of the availability of alternative routes, the costs of the project, environmental factors, long range area planning, and safety concerns, The Board of County Commissioners of Lee County, Florida, desires to exercise its right to condemn property for public use or purpose and that the property to be condemned is necessary for that use.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY FLORIDA, that:

The Capital Improvement Project provides for the construction of the Plantation Road Extension, Project No. 4065, extending from Colonial Boulevard to approximately 600 feet South of Idlewild Street in Fort Myers.

#### SECTION ONE: USE, NECESSITY AND DESCRIPTION OF PROPERTY

The Board of County Commissioners finds that the fee simple rights to property described in the attached Exhibit "A", drainage easement rights to property described in the attached Exhibit "B", slope easement rights to property described in the attached Exhibit "C", bike path easement rights to property described in the attached Exhibit "D" and temporary construction easement rights to property described in the attached Exhibit "E" are necessary for the Plantation Road Extension Project and are being acquired for the following specific public use or purpose:

To improve traffic flow and transportation safety, increase traffic flow for public as well as private vehicles, improve evacuation routes, connect Plantation Road directly to Colonial Boulevard with a four-lane divided roadway, including sidewalk, storm water drainage and utilities.
