9. Background: Lee Mental Health Center, Inc. will receive an amount not to exceed \$2,615,161, for the period beginning July 1, 2006 and ending June 30, 2007, of which none is required for match. \$2,259,045 of county funds will be used to purchase core services including adult and children's mental health services and adult and children's substance abuse services. \$356,116 will be used for operating costs, such as rent and utilities for the VISTA, the home of Lee Mental Health Center's acute care services, which opened in February 2006.

Southwest Florida Addiction Services, Inc. will receive an amount not to exceed \$1,664,355, for the period beginning October 1, 2006 and ending September 30, 2007, of which none is required for match. County funds will be used to purchase core substance abuse services for adults and children.

Children's Advocacy Center of Southwest Florida, Inc. will receive an amount not to exceed \$181, 250 to pay for approximately 725 medical examinations and consultations at the rate of \$250 per exam/consultation.

Contracts will be routed for signature once prepared.
