A REVISER'S ORDINANCE AMENDING APPLICABILITY AND JURISDICTIONAL EFFECTIVENESS OF STATED LEE COUNTY ORDINANCES: PROVIDING THAT CERTAIN LEE COUNTY ORDINANCES SHALL BE APPLICABLE TO AND BE EFFECTIVE WITHIN THE CITY LIMITS OF THE CITY OF BONITA SPRINGS. WHEREAS, Lee County has duly adopted county ordinances for the public's health, welfare, safety and benefit that apply to the unincorporated area of the county; and

WHEREAS, the area presently encompassed within the corporate limits of the City of Bonita Springs, Florida, was subject to said ordinances prior to the incorporation of the City's area on December 31, 1999, pursuant to Chapter 99-428, Laws of Florida (1999); and

WHEREAS, the City as of December 31, 1999, does not have administrative and legislative powers by which to implement and enforce as city ordinances those prior legislative acts of the county, found to be necessary to protect the public health, safety and welfare; and

WHEREAS, F.S. §165.093 provides that a county is to provide that assistance which is reasonably necessary in the formation and implementation of new municipalities; and

WHEREAS, Sec. 63 of Ch. 99-428 states the County is to provide the City residents with all of the same services it provided prior to incorporation until the City Council becomes operative on April 15, 2000; and

WHEREAS, the County, in compliance with the foregoing shall continue county ordinance applicability and jurisdiction within the City limits in order to provide necessary public health, safety and welfare legislation to the City residents as citizens of Lee County;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY FLORIDA:

SECTION ONE: FINDINGS.

The above referenced statements in the preamble are hereby confirmed and incorporated herein as if set out further in this section at length. There is hereby found to be a public need to amend those county ordinances as provided herein to provide continued applicability and effectiveness of same within the City limits of the City of Bonita Springs, Florida, as said city is legally described and set forth in Chapter 99-428, Laws of Florida, (1999).

SECTION TWO: INTENT.

It is the intent of the Lee County Board of County Commissioners to amend each and every ordinance as set out in the following sections to set forth and provide for ordinance applicability, effectiveness and enforcement within the city limits of the City of Bonita Springs as such is described in Chapter 99-428, Laws of Florida (1999), to the same extent and in the same manner as if such City area was within the unincorporated area of Lee County. Upon adoption of this ordinance, all such stated county ordinances will be applicable to, effective and enforceable within the City limits for the period as further provided for herein.

SECTION THREE: GENERAL AMENDMENT

The Lee County ordinances as stated by number, style and general subject description set

forth in the following sections are hereby amended to extend the ordinance coverage, applicability, effectiveness and enforcement to the City of Bonita Springs, Florida, as created by Chapter 99-428, laws of Florida.

SECTION FOUR:

Lee County Ordinance No. 75-09, an ordinance prohibiting the exposure of private parts or female breasts in an establishment at which alcoholic beverages are offered for sale for consumption on the premises; prohibiting the use of any device or covering which simulates private parts or female breasts in an establishment at which alcoholic beverages are offered for sale for consumption on the premises; prohibiting any person owning, maintaining, or operating an establishment at which alcoholic beverages are offered for sale for consumption on the premises from suffering or permitting, on the premises of said establishment, the exposure of private parts or female breasts or the use of any device or covering which simulates private parts or female breasts; legislative authorization; providing for penalties; and

As amended by Lee County Ordinance No. 76-09, an ordinance establishing and regulating the hours for the sale, consumption, service or permitting to be served, of alcoholic beverages and intoxicating liquors within the unincorporated areas of Lee County by places holding a license under the state beverage department of Florida; providing that no alcoholic beverages or intoxicating liquors of any kind may be sold, consumed, served, or permitted to be served or consumed during the week hours (to include Sundays) of 2:00 a.m. and 7:00 a.m of the same day; providing for the prohibition of the on-premise consumption of alcoholic beverages of any kind within five hundred (500') feet of a church or school unless a special permit is first obtained; providing a standard to measure the five hundred (500') feet distance requirement; providing for the repeal of any ordinance or resolution in conflict herewith; repealing a 2,500 feet distance

requirement from a church or school; providing for civil and criminal penalties; and

As amended by Lee County Ordinance No. 79-01, an ordinance amending Lee County Ordinance No. 76-09; relating to the sale, consumption and service of alcoholic beverages; relating to special permits for on-premise consumption of alcoholic beverages and prohibition of same within 500 feet of a church or school and providing for measurement criteria for said distances; amending the measurement requirement to provide same on a straight-line from the main entrance of on-premise consumption establishment to the property line of church or school, are hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION FIVE:

Lee County Ordinance No. 84-01, an ordinance to prohibit any person from drinking or consuming alcoholic beverages on a semi-public parking lot or public way, parking lot, or beach and to prohibit the transporting, carrying, or possession of alcoholic beverages, except in the original package and with the seal unbroken, on a semi-public parking lot or public way, parking lot, or beach in the unincorporated area of Lee County; providing for exemption; providing for penalty;

As amended by Lee County Ordinance No. 84-11, an ordinance amending Lee County Ordinance No. 84-01 relating to drinking alcoholic beverages or possessing alcoholic beverages in public; amending definition of alcoholic beverage; providing exemptions; and

As amended by Lee County Ordinance No. 93-06, an ordinance amending Lee County Ordinance No. 84-01 relating to the prohibition of any person from transporting, carrying or possessing alcoholic beverages in an open container; providing that open container of alcoholic beverage while operating a vehicle shall be punishable, under F.S. Sec. 316.1936 as a non-criminal moving traffic violation; amending penalty section, are hereby amended to include the

City of Bonita Springs and to be effective therein.

SECTION SIX:

Lee County Ordinance No. 90-51, an ordinance relating to vessel control and water safety; providing for title, purpose and authority; providing for definitions; providing for areas of enforcement and means of enforcement; providing for vessel regulation including speed, careful and prudent operation required, areas of prohibited water activity, areas of special management and regulations for operation of personal watercraft; providing for regulations for personal watercraft rentals; providing for procedures to designate areas; providing exemptions; providing for penalty; providing for repealer, conflicts; and

As amended by Lee County Ordinance No. 90-63, an ordinance amending Lee County vessel control and water safety Ordinance No. 90-51, so as to clarify certain section of the ordinance and re-adopt Section Six F. Relating to prohibited personal watercraft activity within waters of the Captiva Island shoreline; providing for amendments to Section Three C, Definition of Floating Vendor; Section Five, Means of Enforcement; Section Six C, Areas of Prohibited Water Activity; Section Six F, Areas of Prohibited Personal Watercraft Activity; and Section Nine C, Exemption for Commercial Vessels; and

As amended by Lee County Ordinance No. 91-16, an ordinance amending Lee County Vessel Control and Water Safety Ordinance No. 90-51, as amended, so as to clarify regulations for personal watercraft rentals and to regulate personal watercraft floating vendors; providing for amendments to Section Three, Definitions and Section Seven, Regulations and Locations for Personal Watercraft Rentals, are hereby amended to include the City of Bonita Springs and to be effective therein

SECTION SEVEN:

Lee County Ordinance No. 90-03, an ordinance providing for local enforcement of the water shortage plan of the South Florida Water Management District; providing definitions; providing for application of ordinance; providing for enforcement and penalties; and

As amended by Lee County Ordinance 91-24, which establishes local enforcement of the water shortage plan of the South Florida Water Management District; providing for a title; providing for amendments to definitions; creating permanent water restrictions, providing for amendments to declaration of water shortage, are hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION EIGHT:

Lee County Ordinance No. 95-14, an ordinance repealing and replacing Lee County Ordinance No. 90-61 to better manage recovery, reconstruction and mitigation activities following a major or catastrophic disaster within the unincorporated areas of Lee County, Florida; providing for the purpose and intent of the ordinance; providing for jurisdiction; providing definitions; providing for the creation, composition, duties and responsibilities, duration, and chair of a disaster advisory council; providing for the creation, duration, duties and responsibilities of a post-disaster recovery task force and certain members thereof; providing for the composition and duties of an emergency review board; providing priorities for post-disaster redevelopment; providing priorities for essential services and facilities restoration; providing debris clearance, removal and disposal strategies; providing for determination of damage; providing for implementation of a build back policy; providing for a declaration of an initial building moratorium and establishing related moratoria pertaining to building permit inspections, development orders and site plans providing provisions for meratoria; providing for emergency repairs, providing for

an emergency permitting system; providing policies for economic redevelopment; providing guidelines for acquiring damaged property; providing for authority; and providing penalties, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION NINE:

Lee County Ordinance 88-24, an ordinance repealing and replacing Ordinance No. 74-11, relating to minimum standards of hygiene for food establishments and food vendors, stating the purpose of the ordinance, adopting sections of the Florida Administrative Code, setting forth definitions and permit requirements providing for non-transferability of permits, approval of plans, providing for a food hygiene certification program, providing for inspections, approval, revocation of permits, closing of establishments, control of unsafe food and drink, mobile and roadside food vendors; establishing a hearing review board; providing for appeal from orders, enforcement and penalties, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TEN:

Lee County Ordinance 91-01, an ordinance providing for the mandatory connection of onsite sewage disposal systems to publicly owned or investor-owned wastewater collection systems after notice that such a system is available; providing for definitions; providing for an administrative waiver of the mandatory connection, providing for penalties, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION ELEVEN:

Lee County Ordinance No. 93-10, an ordinance relating to removal of recyclable materials from county containers for collection; providing for definitions; providing for prohibitions; providing for penalties, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TYPE: VE:

Lee County Ordinance No. 93-23, an ordinance repealing and replacing Lee County Ordinance No. 86-05, as amended by Lee County Ordinance No. 88-42, relating to nuisance grasses and weeds; providing for repealer, providing for short title and territorial scope; providing for definitions, providing for nuisance declared; providing for prohibitions; providing for designation of investigating and enforcing authority; providing for procedures for implementation; providing for budget of funds; providing for civil remedies; and providing for conflict, are hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTEEN:

Lee County Ordinance No. 93-39, an ordinance amending and restating Lee County Ordinance No. 88-43, governing the regulation and disposal of garbage, refuse, trash, rubbish, lost or abandoned property or inoperable vehicles by prohibiting the dumping of such material on private property; providing for removal of accumulations of refuse, trash, rubbish, lost or abandoned property or inoperable vehicles; amending the definition of nuisance accumulation; providing for a definition of inoperable vehicle; providing for prosecution before a hearing examiner; and providing for penalties, are hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION FOURTEEN:

Lee County Ordinance No. 95-08, as amended by Lee County Ordinance No. 95-19, and as subsequently amended, an ordinance amending and restating Lee County Ordinance No. 86-14, as amended, relating to garbage and solid waste collection and disposal for Lee County; creating certain municipal service benefit units within Lee County to be known as mandatory solid waste collection and disposal units for service area; providing for the purpose of disposing of solid waste within their boundaries; establishing the governing body with powers and duties; providing

for residential and commercial collection and disposal; mandating services and payment for same; levying special assessments and collection; prohibiting unlawful disposal; and penalties, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION FIFTEEN:

Lee County Ordinance No. 95-10, as amended by Lee County Ordinance No. 95-20, and as subsequently amended, an ordinance relating to Lee County Garbage and solid waste disposal facilities; creating a municipal service benefit unit within Lee County for commercial solid waste service customer disposal facilities costs; establishing the governing body with powers and duties; levying certain special assessments for costs of Lee County solid waste disposal facilities from commercial solid waste service properties; providing for penalties, severability, supplemental authority, repeal of provisions of inconsistent ordinances, and effective date, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION SIXTEEN:

Lee County Ordinance No. 91-07, an ordinance regulating solid waste transportation within Lee County, Florida, providing for purpose and authority; providing for definitions; providing for regulation and enforcement; and providing for penalties, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION SEVENTEEN:

Lee County Ordinance No. 88-54, an ordinance relating to escort service businesses, providing for definitions, providing for county permit to conduct business, providing for disclosure of escort service business records, providing for age limitation, providing for county license to be employed as an escort; and providing for penalties, is hereby amended to include the City of Bornia Springs and to be effective therein

SECTION EIGHTEEN:

Lee County Ordinance No. 85-07, an ordinance relating to the licensing of transient merchants within Lee County; providing definitions; providing prohibition; providing exemptions; providing for a permit; providing for the content of applications; providing for a fee; permit not transferable; bond required; providing for service of process; background investigation required; creating the licensing review board; providing for issuance or denial; providing for revocation of permit and criteria; providing one year duration of permit; requiring the display of permits; providing enforcement; and providing a penalty; and

As amended by Lee County Ordinance No. 88-17, an ordinance amending the transient merchant ordinance, to provide for proper reference to the current commercial use of rights-of-way Ordinance, No. 88-11, as may be amended or replaced; to provide for conflict, are hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION NINETEEN:

Lee County Ordinance No. 88-11, as amended, relating to the Commercial Use of Rights-of-Way; rules and regulations; and providing penalties, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TWENTY:

Lee County Ordinance No. 94-32, as subsequently amended, an ordinance amending and restating Lee County Ordinance No. 94-16, relating to fireworks and sparklers; providing a short title, applicability and purpose; providing for sale of fireworks; providing for definitions; prohibiting fireworks from being distributed, stored or sold at roadside stands; providing for outdoor display of fireworks, providing for pyrotechnic displays before a proximate ordinance; providing for penalties, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TWENTY ONE:

Lee County Ordinance No. 95-13, an ordinance creating a personal watercraft rental vendor and parasailing license ordinance; providing for title, purpose and authority; providing definitions; prohibiting unlicenced rental of personal watercraft or parasailing; providing for application and regulatory fee; providing for annual license fee; providing for renewal and display of license; providing for conditions of licensing use by personal watercraft vendors or parasailing operators; providing for transferability of the vendor license and a grandfather clause; providing for insurance, regulatory penalties and exemptions; providing for areas of enforcement and means of enforcement, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TWENTY-THREE:

Lee County Ordinance No. 94-27, an ordinance of Lee County, Florida, pertaining to the towing of vehicles parked on private preperty; relating to the towing and removal of vehicles from

private property without the consent of the registered owner or other person in control of the vehicle; providing for supplemental authority to F.S. §715.07, regulation of maximum service rates and minimum insurance regulations; definitions, intent and non-solicitation; and penalty, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TWENTY-FOUR:

Lee County Ordinance No. 93-15, as subsequently amended, an ordinance amending and restating in its entirety the Lee County Noise Control Ordinance No. 82-32, as amended, so as to provide clarification and provide for various amendments; amending Section Three, Definitions; amending Section Six, Exceptions, to clarify that the sheriff's department may charge individuals with breach of the peace; adding Section Eight, Enforcement, to empower the sheriff's department with the enforcement of the ordinance; and amending Section Nine, Penalties; and

As amended by Lee County Ordinance No. 94-17, an ordinance amending the Lee County Noise Control Lee County Ordinance No. 93-15, so as to revise the criteria for maximum permissible sound levels; to provide specific prohibitions during certain hours from sounds emanating from radios, televisions, loudspeakers, sound amplifiers and other mechanical devises or instruments which are plainly audible; and set forth criteria for plainly audible sound, are hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TWENTY-FIVE:

Lee County Ordinance No. 85-04, an ordinance relating to sleeping on public beaches; providing territorial scope; providing for means of enforcement; providing for legislative intent; providing for regulation of sleeping on beaches being prohibited except between certain times; and providing for penalty, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TWENTY-SIX:

Lee County Ordinance No. 91-26, an ordinance creating the Lee County special events ordinance regulating outdoor entertainment events; providing for repealer; defining outdoor entertainment events; establishing license requirements and application procedures; requiring proof of insurance and proof of a bond; providing for the filing of complaints; providing for revocation of licenses; providing for enforcement, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TWENTY-SEVEN:

Lee County Ordinance No. 91-11, an ordinance repealing Ordinance No. 87-07 and restating and establishing the Lee County Well Code; relating to administration, permitting standards, construction, repair, and plugging of water wells; establishing a well construction advisory board; providing permitting procedures; providing regulations relating to test wells, testing reports and inspections, water well permits, construction and abandonment of water wells; providing for licensing; providing for supplemental regulations; providing for specialty licenses; providing for penalties, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TWENTY-EIGHT:

Lee County Ordinance No. 95-18, as amended, an ordinance of the Board of County Commissioners of Lee County, Florida, to be entitled the "Lee County Sexually Oriented Businesses Regulation Ordinance;" providing for purpose and intent; providing for applicability to the unincorporated areas of Lee County, Florida; providing for definitions; providing for classification of sexually oriented businesses; providing for the requirement of a permit for operating sexually oriented businesses; providing for investigation of applications for permits;

providing procedures for the issuance or denial of permits; providing for an annual permit fee; providing for inspection of the premises of sexually oriented businesses; providing for expiration of permits; providing for suspension of permits; providing for revocation of permits; providing for judicial review of permit denial, suspension or revocation; providing for restrictions regarding the transfer of permits; prohibiting back room lingerie modeling; providing for prohibitions regarding minors and sexually oriented businesses; providing for advertising regulations; providing for hours of operation; prohibiting "straddle dancing" and other sexual activities at sexually oriented businesses; providing for exemptions; providing for criminal penalties and additional equitable and injunctive relief; providing for consent by permittees to the provisions of this ordinance and to county, federal, state and municipal regulations; providing for immunity from prosecution; providing for notice requirements under this ordinance; and providing for severability, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION TWENTY-NINE:

Lee County Ordinance No. 85-45, as amended by Lee County Ordinance No. 99-07, relating to the possession and use of explosives; providing for permits, applications and prerequisites to issuance and fees; providing for pre-blact notification and inspection, measurement and recordings; providing for revocation and appeals, are hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTY:

Lee County Ordinance No. 89-05 providing for the construction, operation, regulation and control of cable television systems; providing for franchising, system regulations, rate schedules and service requirement and cable systems construction, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTY-ONE:

Lee County Ordinance No. 95-11, as amended, creating the Lee County Occupational License Tax; providing for reclassifications, service fees, permit issuance and new rate structure, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTY-TWO:

Lee County Ordinance No. 96-20, relating to contractor Licensing in Lee County; providing for Construction Licensing Board, certificates of competency and licensure regulations and violations, citations, remedies and actions against unlicenced contractors, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTY-THREE:

Lee County Ordinance No. 97-04, relating to pari-mutuel wagering facilities and the conducting of cardroom games at pari-mutuel wagering facilities, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTY-FOUR:

Lee County Ordinance No. 97-15, granting to Florida Power and Light Company an electric utility franchise; providing for franchise provisions and conditions; providing for payments to Lee County, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTY-FIVE:

Lee County Ordinance No. 97-16, amending Lee County Ordinance No. 78-4, as amended, relating to rules and regulations for sewer service; providing for regulations for grease interceptors, inspections and monthly service charges, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTY-SIX:

Loe County Ordinance No. 98-10, providing for animal control and establishment of county

pound; providing for animal control enforcement, prohibitions against cruelty to animals; providing for animal welfare rules and regulations, enforcement and fees; providing for licensing and vaccination requirements, inspections and quarantine, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTY-SEVEN:

Lee County Ordinance No. 98-24, creating the Bonita Springs Streetscaping Unit; providing for special improvements, governing body, types of service and power to levy charges, assessments or taxes within the unit, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTY-EIGHT:

Lee County Ordinance No. 99-04, relating to the prohibition on the throwing or depositing of litter in public places; providing for fines and penalties, is hereby amended to include the City of Bonita Springs and to be effective therein.

SECTION THIRTY-NINE:

Lee County Ordinance No. 99-14, entitled Motor Vehicle Title Loans; providing for the regulation of the motor vehicle title loan pusiness; providing for conditions to conduct business and maximum interest rates; providing for violations, penalties and enforcement, is hereby amended to include the City of Bonita Springs and to be effective therein.

<u>SECTION FORTY</u>: <u>SEVERABILITY</u>

The provisions of this ordinance are severable and it is the legislative intention to confer upon the whole or any part of the ordinance the powers herein provided for. If any of the provisions of this ordinance shall be held unconstitutional by any court of competent jurisdiction, the decision of such court shall not affect or impair any remaining provisions of the ordinance.

It is hereby declared to be the legislative intent that this ordinance would have been adopted had such unconstitutional provision not been included herein.

SECTION FORTY-ONE: CONFLICTS OF LAW

Whenever the requirements or provisions of this ordinance are in conflict with the requirements or provisions of any other lawfully adopted Lee County ordinance or Florida Law or Statute, the more restrictive will apply.

SECTION FORTY-TWO: CODIFICATION, INCLUSION IN CODE AND SCRIVENER'S ERRORS

It is the intention of the Board of County Commissioners that the provisions of this ordinance shall become and be made a part of the Lee County Code; and that sections of this ordinance may be renumbered or re-entered and that the word "ordinance" may be changed to "Section," "article," or such other appropriate word or phrase in order to accomplish such intention; and regardless of whether such inclusion in the code is accomplished, sections of this ordinance may be renumbered or re-entered and typographical errors which do not affect the intent may be authorized by the County Administrator, or his designee, without need of public hearing, by filing a corrected or recodified copy of same with the Clerk of Circuit Court.

SECTION FORTY-THREE: PENALTY

Any violation of this ordinance may be punished as provided in Sec. 125.69, Fla. Statutes, with a fine not to exceed \$500.00 or by imprisonment for a period not to exceed sixty (60) days, or by both said fine and imprisonment.

SECTION FORTY-FOUR: SUNSET PROVISION/REPEALER

This Reviser's Ordinance amendment specifically amending existing Lee County Ordinances to provide applicability to the City of Bonita Springs, Florida, shall be deemed repealed and of no further force or effect as of April 16, 2000. This provision shall not affect the

continued applicability or effectiveness of said county ordinances to the unincorporated area of Lee County, and said ordinances shall remain in full force and effect as to unincorporated Lee County.

SECTION FORTY-FIVE: EFFECTIVE DATE

This ordinance shall take effect immediately upon "filing" per F.S. §125.66 as revised with the Secretary of State of Florida.
