## LEE COUNTY, FLORIDA EMERGENCY RESOLUTION NO. 23-12-26 SEVENTEENTH EXTENSION OF STATE OF LOCAL EMERGENCY COUNTYWIDE

WHEREAS, Florida Governor Ron DeSantis issued Executive Order 23-171 on August 26, 2023, declaring a State of Emergency for several counties, including Lee County, in anticipation of the impacts of Hurricane Idalia; and

WHEREAS, Florida Governor Ron DeSantis issued Executive Order Number 23-212 on October 24, 2023, extending Executive Order 23-171, as amended by Executive Order Numbers 23-172 (issued on August 28, 2023), 23-174 (issued on August 29, 2023), and 23-175 (issued on August 29, 2023), to renew the State of Emergency for the State of Florida for sixty (60) days, because recovery efforts and those affected by this disaster require continued support of the State of Florida; and

WHEREAS, Florida Statutes Section 252.38(3)(a)(5) provides authority for political subdivisions to declare a State of Local Emergency and to waive the procedures and formalities otherwise required of political subdivisions in order to take whatever action is

necessary to ensure the health, safety, and welfare of the community; and

WHEREAS, Chapter 252 of the Florida Statutes limits the duration of each State of Local Emergency to seven (7) days and it may be extended, as necessary, for additional terms in seven (7) day increments; and

WHEREAS, Hurricane Idalia has caused personal injury and extensive damage to commercial, residential and public structures of Lee County; and

NOW, THEREFORE, IT IS RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA this 25<sup>th</sup> day of December 2023:

- 1. That the effects of Hurricane Idalia continue to pose a serious threat to the lives and property of the residents of Lee County and that an extension of a State of Local Emergency is declared, effective immediately for all unincorporated and incorporated areas within the local boundaries of Lee County, Florida.
- 2. The Resolution No. 23-09-02 Declaring a State of Local Emergency is hereby extended for an additional seven (7) day increment.

BE IT FURTHER RESOLVED that the Board of County Commissioners hereby exercises its authority and waives the procedures and formalities required by law of a political subdivision, as authorized under §252.38, Florida Statutes.
