RESOLUTION DECLARING COUNTY-OWNED PROPERTY AS SURPLUS LANDS AND CONVEYANCE AUTHORIZING TO THEIR QUALIFIED NOT-FOR-PROFIT CORPORATIONS **ESTABLISHED** FOR THE **PURPOSE** PROMOTING PUBLIC OR COMMUNITY INTEREST AND WELFARE OR SALE. WHEREBY PROCEEDS ARE APPLIED TO THE COUNTY'S AFFORDABLE HOUSING TRUST FUND ACCOUNT.

WHEREAS, the Board of County Commissioners is the governing body for Lee County, a political subdivision of the State of Florida; and

WHEREAS, the Board has certain powers and authority relative to the disposition of real property belonging to the County; and

WHEREAS, Florida Statutes §§ 125.379 and 125.38 authorizes the conveyance of County property to a not for profit organization or corporation, if that property will be used for promoting community interest and welfare; and

WHEREAS, Lee County has reviewed its real property inventory and identified 65 vacant lots available for affordable housing purposes, pursuant to Florida Statutes §125.379; and

WHEREAS, the 65 vacant lots are described and identified in **Exhibit "A"** attached hereto: and

WHEREAS, Lee County received 2 lots (real property) by donation and 63 vacant lots (real property) through the property tax escheatment process; and

WHEREAS, the Board has confirmed through its staff that such real property is not needed for County purposes; and

WHEREAS, it is the intent of this resolution to declare the properties in Exhibit "A" as surplus land of the County and available to convey to qualified not for profit organizations or corporations upon their submittal of a conveyance application for the purpose of constructing affordable housing thereupon, or make available for sale through Lee County's Surplus Lands Ordinance process, and apply land sale proceeds to County's Affordable Housing Trust Fund; and

WHEREAS, a statement evidencing publication of the Notice of Public Hearing on this resolution declaring County-owned property as surplus lands and authorizes their conveyance to qualified not-for-profit corporations established for the purpose of promoting public or community interest and welfare, or for sale in accordance with Lee County Ordinance 02-34,

whereby sale proceeds will be applied to the County's Affordable Housing Trust Fund Account, is entered into the minutes of the County Commission Meeting; and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Lee County, Florida, that:

- 1. The above recitations are true and accurate and are hereby adopted and incorporated herein as if set out at length.
- Lee County has concluded that the real property (65 lots) described in Exhibit "A" are surplus lands and not needed for County purposes. Lee County has further concluded that the real property described in Exhibit "A" are appropriate for use as affordable housing.
- 3. Lee County will consider the future applications of qualified not for profit organizations or corporations to acquire the property for the purpose of providing affordable housing, on a case by case basis, conditioned that the use complies with the statutory requirement that the property be used for public or community interest and welfare.
- 4. The County agrees to convey the property to qualified not-for-profit organizations or corporations for nominal consideration of one dollar (\$1.00).
- 5. The County Lands Director is authorized to offer any of the 65 lots for sale through the disposition methods set forth in County Ordinance 02-34, Section 5(B)(1), with any land sale proceeds to be directed to the Affordable Housing Trust Fund, in accordance with Fla. Stat. § 125.379(2). Acceptable lot sales will be brought before the Board requesting conveyance approval and acknowledge incoming funding for the Affordable Housing Trust Fund.
