

## Courtesy Notice - Preview Comments Report

This feature gives the public access to preview the review comments of Permitting records prior to the official Rejection Letter being issued. This will allow applicants the ability to prepare their resubmittal responses and plan corrections while the remaining reviews are underway, essentially reducing the amount of time between submittals.
