

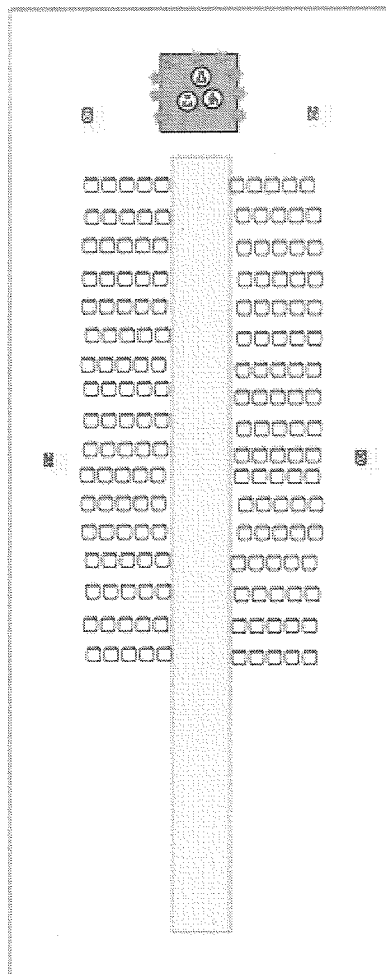

Extra Duty Details will not be provided to any person, firm or organization whose standards, business or operations are of questionable nature, or for any event that will obstruct the assigned Deputy, Sheriff's Office or County. The Sheriff's Office reserves the right to cancel the detail without refund and at recall the deputies when necessary for community safety.

The Lee County Sheriff's Office will be the only armed personnel at any event where the detail is located. Any private security company that is hired to work alongside the Sheriff's Office will be a regulated, licensed and bonded company whose employees are Class C bonded and must carry security guards. Proof of the signed contract with private security company will be required.

In order to receive a detail, notice must be given to the Detail Coordinator twenty (20) hours prior to the start of the detail either by phone or email. If the coordinator is less than twenty four (24) hours, a four (4) hour charge per deputy will be billed. In the case of weather, notice of cancellation must be received which two (2) hours of the starting time otherwise a two (2) hour charge per deputy will be billed by the start of a cancellation after business hours, please call 230-577-1000 and ask to have them call Detail Coordinator call you.

Unless otherwise specified, all payment of all details must be received one (1) week prior to the start of the event in the form of a cashiers check, money order, money check or cash. The Lee County Sheriff's Office does not accept credit cards or personal checks.
