Dear County Manager Harner:

This letter acknowledges receipt of correspondence dated September 30, 2025, sent by Billie Jacoby (Lee County Floodplain Administrator), regarding the preliminary Flood Insurance Rate Maps (FIRMs) and Flood Insurance Study (FIS) for Lee County, FL issued July 25, 2024. This correspondence was initiated on behalf of the engineering firm J.R. Evans Engineering regarding floodplain mapping within the Westbrook Development residential area within Lee County Unincorporated Areas. The primary area of proposed change is located within the vicinity of Westbrook Development, located on preliminary FIRM panel 12071C0581G. Please note that only those submittals that relate to the addition or modification of the proposed flood hazard information (i.e., Base Flood Elevations, base flood depths, Special Flood Hazard Area boundaries, zone designations, or regulatory floodways) shown on the FIRM and in the FIS report that satisfy the data requirements defined in Title 44, Chapter I, Part 67 of the Code of Federal Regulations are considered appeals. Because your submittal did not meet these criteria, FEMA has processed it as a 'comment.'

After reviewing this submittal, FEMA agrees to accept and address the suggested zone changes from AH to AE, AH to X-Shaded and X-Shaded to X-Unshaded (and vice versa) as a comment to update the preliminary FIS and FIRMs issued July 25, 2024. Mapping revisions were applied to preliminary FIRM panel 12071C0581G. The changes to this panel impact the mapping of Special Flood Hazard Areas, but do not revise the modeling results.

As a result of the comments received, Compass conducted a thorough review of the FIRMs and incorporated additional changes to panels. The following list contains the revised preliminary FIRM panels within Lee County Unincorporated Areas:
