The CoC's Performance Evaluation and Ranking Committee has been meeting at least quarterly since January 2019. Each meeting the committee reviews report cards for each CoC funded project. Report cards include a review of the projects success in achieving local performance standards, data quality, timely spending, and participation in the CoC. Upon review and discussion regarding Salvation Army (TSA) performance and the community need for RRH that serves individuals, the Committee elected to recommend partial reallocation to the Governing Board, who approved the reallocation on May 7, 2019. Notification was sent via email and letter to TSA on May 14, 2019. The amount being reallocated was based on two case managers currently dedicated to the RRH Program having a maximum caseload of 20 households each.
