



NOTICE OF PUBLIC COMMENT PERIOD

For Amendments to the Lee County Annual Action Plans

In accordance with U.S. Department of Housing and Urban Development (HUD) regulations governing Community Development Block Grant (CDBG), Community Development Block Grant Cares Act (CDBG-CV), HOME Investment Partnerships Program (HOME), and HOME Investment Partnerships American Rescue Plan Program (HOME-ARP), Lee County hereby notifies the public that a public comment period will be held from January 17, 2026 through February 16, 2026 to receive comments on proposed amendments to the HUD 2020, 2021, 2022, 2023, 2024, and 2025 Annual Action Plans. The proposed amendments are listed below and may be viewed on the County website at leegov.com/dhs/about/contracts. All comments will be considered in preparing the final amendments and reported in the documents submitted to HUD.

Program Year 2020

- Transfer \$83,948.34 in HOME funds from Non-Profit Housing to HOME Tenant-Based Rental Assistance.
- Transfer \$56,839.86 in CDBG-CV funds from Program Administration funds to CDBG-CV Public Services.
- Transfer \$9,639.54 in CDBG-CV funds from Public Facilities to CDBG-CV Public Services.

Program Year 2021

- Transfer \$175,100 in HOME funds from Down Payment Assistance to HOME Tenant-Based Rental Assistance.
- Transfer \$272,000 in HOME funds from Non-CHDO Housing Development to HOME Tenant-Based Rental Assistance.
- Transfer \$350,000.00 in HOME-ARP funds from Non-CHDO Housing Development funds to HOME-ARP Tenant-Based Rental Assistance.
- Transfer \$9,321.55 in CDBG funds from Non-Profit Capital Improvement to CDBG Owner-Occupied Housing Rehabilitation.

Program Year 2022

- Transfer \$103,700 in HOME funds from Program Administration to HOME Tenant-Based Rental Assistance.
- Transfer \$30,115.71 in HOME funds from Non-Profit Housing Development to HOME Tenant-Based Rental Assistance.
- Transfer \$39,831.38 in CDBG funds from Public Services to CDBG Owner-Occupied Housing Rehabilitation.
- Transfer \$12,721.00 in CDBG funds from Non-Profit Capital Improvement to CDBG Owner-Occupied Housing Rehabilitation.

Program Year 2023

- Transfer \$5,832.68 in CDBG funds from Public Services to CDBG Owner-Occupied Housing Rehabilitation.

Program Year 2024

- Transfer \$121,512.86 in CDBG funds from Public Services to CDBG Non-Profit Capital Improvement.
- Transfer \$328,368.00 in HOME funds from Down Payment Assistance to Non-Profit Housing Development, which will be added as a new HOME-funded project in the PY24 Annual Action Plan.

Program Year 2025

- Transfer \$70,056.00 in CDBG funds from Program Administration funds to CDBG Public Services.
