

Notice of Public Comment Period for the GS-10 Drainage Basin Project and the Iona McGregor Drainage District Project



Two applications for drainage projects through the Department of Economic Opportunity are available for public review. The Rebuild Florida General Infrastructure Program (GIP) is administered by the State of Florida Department of Economic Opportunity (DEO). This Program is funded by the U.S. Department of Housing and Urban Development (HUD) Community Development Block Grant - Mitigation (CDBG-MIT) allocation as described in Public Law 115-123. Lee County is applying to the CDBG-MIT-GIP cycle II with a project in the GS-10 Drainage Basin and a project in the Iona McGregor Drainage District. The goal of these projects is to mitigate critical existing surface water management issues, to improve living environments, and to expand economic opportunities for low-to-moderate income persons with grant funds provided by HUD.

The applications can be viewed on the County website at www.leegov.com/dhs/about/contracts. Public comment will be accepted August 10, 2021 to August 25, 2021. All comments will be considered in preparing the final applications to be approved at the Board of County Commissioners meeting on September 7, 2021.

Proposed GS-10 Drainage Basin Project:

- \$11,025,000 million: Lee County will request funding to build a filter marsh, add weirs, and create water storage within an existing lake in east Lee County to mitigate the risk of flooding in Lehigh Acres and other areas of unincorporated east Lee County. This project will also improve water quality, restore more natural flows to the Greenbriar Swamp and the headwaters of Hickey Creek, and improve storm water management for Hickey and Bedman creeks.

Proposed Iona McGregor Drainage Project

- \$3.2 million: Reestablish 6 miles of Iona McGregor Drainage District canals to original cross-sections, which includes removal of vegetation and silt.
