Proposed Project and Capacity to Succeed

Lee County proposes to replace sidewalks and related drainage systems that were damaged by heavy equipment and vehicles used to restore utility service and remove debris in eight low- and moderate-income neighborhoods in the aftermath of Hurricane Irma. Damaged drainage systems and sidewalks increase the risk of future flooding and threaten the market value of an important source of affordable housing stock.

Lee County has sufficient capacity, experience and fiscal reserves to manage this project, which will be coordinated by our Department of Transportation. Lee DOT staff has decades of experience and currently manages 460 miles of sidewalks with related drainage systems countywide. In addition, Lee County's Human and Veteran Services Department has managed more than \$8 million in CDBG sidewalk and drainage construction.


Charleston Park Neighborhood




