

LEE COUNTY RESOLUTION NO. 21-06-15

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEE COUNTY, FLORIDA, FOR DESIGNATION OF ALICO ROAD AS A CONTROLLED ACCESS ROAD AND ESTABLISHMENT OF PERMANENT ACCESS POINTS.

WHEREAS, section 10-298 of the Lee County Land Development Code provides for the designation of certain streets in Lee County as "controlled access" facilities to which permanent access points are restricted to locations established and set by design study and plans adopted by resolution of the Lee County Board of County Commissioners; and

WHEREAS, the Board of County Commissioners retains the right and authority to exercise its police power to modify roadway median openings, access points and turning movements to protect the health, safety, and welfare of the traveling public; and

WHEREAS, Alico Road, from Airport Haul Road to Immokalee Road is currently subject to environmental and engineering design; and

WHEREAS, establishing Alico Road, east of Ben Hill Griffin Parkway as a limited access facility with fixed access points will be in the best interest of the public;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Lee County, Florida, that:

1. Alico Road (CR 840), from Ben Hill Griffin Parkway (CR 885) north and east to Immokalee Rd (SR 82) including its intersections, is designated a controlled access road facility.
2. At the time of the designation as a controlled access facility, the resolution will identify authorized access points in an exhibit to the resolution. Exhibit A lists the approximate locations and descriptions of access points and are shown on map as Exhibit B. These will be refined as environmental and engineering design proceeds.
3. It is the intention of the Board that once designated, no public or private road, driveway, or other type of access may connect to Alico Road without the prior approval of the Board expressed by a supermajority vote. The County retains full power and authority to exercise its police power to modify connection points, median openings, and turning movements to protect the health, safety, and welfare of the traveling public.

Commissioner Mann made a motion to adopt the foregoing resolution, seconded by Commissioner Hamman. The vote was as follows:




