1. Road Work/Maintenance/Improvements:

Alico Road Widening from Ben Hill Griffin Parkway to west of Airport Haul Road -Construction Project: This project consists of widening Alico Road to four lanes. The project also includes medians and multi-use paths.

- Lee County Department of Transportation urges bicyclists to avoid Alico Road between Ben Hill Griffin Parkway and Airport Haul Road. This is an active construction site with limited shoulders and should be avoided for safety purposes.
- Expect large vehicles entering and exiting Alico Road. Motorists should use caution in the area.

Estero Boulevard Construction – reFRESH Estero Boulevard/Waterlines – Strandview Avenue to the south end of the island.

Contractors for Fort Myers Beach and Lee County are installing new water main, and sanitary sewer force main, storm drainage, sidewalk and rebuilding roadway on Estero Boulevard from Strandview Avenue to the south end of the Island. <u>Motorists may experience daytime and nighttime intermittent one-lane traffic on Estero Boulevard. Flaggers will alternate traffic frequently, but motorists should expect delays.</u> Motorists may experience momentary delays while crews move materials for the construction activities. Additional work includes installing drainage structures, pedestrian signals, upgrading signals and lighting, and resurfacing existing highway. The project will be constructed in three segments. Each segment will have the majority of construction completed prior to moving to the next segment. Construction is ongoing on Segment B, Phase 1 from Halgrim Avenue to Katherine Street. Crews will work on the west side of the road initially and when that work is completed, they will shift to the east side of Cleveland Avenue/US 41. The expected project completion date is the **end of spring 2022**. The Contractor is Ajax Paving Industries of Florida, LLC.

Winkler Road at College Parkway – Fort Myers (ROW2020-00289): Caloosa Site Development, Inc. will be performing roadway and sidewalk improvements beginning Tuesday, June 16, 2020 and continue through **August 30, 2020**. Asphalt pavement, concrete sidewalk, concrete curbing, and drainage improvements will be performed. The outside (right) lane of southbound traffic on Winkler Road just after College Parkway will be subject to lane closures, as will one of two left turn lanes from the westbound portion of College Parkway turning south onto Winker Road. Periodic lane closures for northbound and southbound lanes will occur between the hours of 9:00 a.m. and 3:30 p.m. on weekdays. Winkler Road Sidewalk Project: Lee County DOT along with Denco Construction will be making improvements on Winkler Road between College Parkway and McGregor Boulevard. Work will include water main replacement, drainage improvements and a new sidewalk along the east side of Winkler. The project is expected to begin on Monday, February 24, 2020 and be completed by **December 2020**.
