5<sup>th</sup> Street West, Lehigh: Stevens and Layton, Inc. will be installing storm drainage and connecting the two sections of 5<sup>th</sup> St W over the Cobia Canal off Sunshine Blvd in Lehigh Acres. The work will begin on Wednesday, October 20, 2021 and will be completed in 60 days. There will be no impacts to current traffic patterns, business or residential access during this work. Alico Road near Centerplace Boulevard, Fort Myers (ROW2021-00127): Haskins, Inc. will be adding a left turn lane on Alico Road heading west.
