Roadwatch Update
August 18, 2022 – August 24, 2022

1. Road Work/Maintenance/Improvement

Striping Maintenance: Lee County DOT will be performing a moving operation with traffic delays on **8-18-22 through 8-24-22** between the hours of **9:00 AM to 4:00 PM**. (weather permitting) on the following roadways:

Intersection Markings: Intermittent lane closures and delays are possible on **8-18-22 through 8-24-22** between the hours of **9:00 AM to 4:00 PM** (weather permitting) on the following roadways:

Burnt Store Road from Tropicana Parkway to Pine Island Road: This project consists of widening Burnt Store Road to four lanes. The project also includes construction of a new bridge over Shadroe Canal, drainage installation, and lighting. Motorists should expect intermittent Northbound and Southbound lane closures during nighttime/overnight hours, weather permitting. Motorists should use caution while driving in the area. This south segment from Tropicana Parkway to Pine Island Road costs \$13.6 million. The contractor is Wright Construction. The project is expected to be completed by late Fall 2022. Beginning on June 19, 2022, motorists should expect a new traffic pattern where the northbound traffic will be shifted onto the newly constructed lanes. reFRESH Estero Boulevard/Waterlines - Albatross Street to the south end of the Island:

Contractors for Fort Myers Beach and Lee County are installing new water main, and sanitary sewer force main, storm drainage, sidewalk, and rebuilding roadway on Estero Boulevard from Albatross Street to the south end of the Island. Motorists may experience daytime and nighttime intermittent one-lane traffic on Estero Boulevard. Flaggers will alternate traffic frequently, but motorists should expect delays. Motorists may experience momentary delays while crews move materials for the construction activities. Crews are expected to work **Monday through Friday and most Saturdays**. **Albatross Street to the south end of the island**. Motorists may experience daytime lane shifts on Estero Boulevard while crews complete punch list items. This schedule may be subject to change due to inclement weather. Corkscrew Road Widening Project – Phase I Construction Project: The project widens Corkscrew Road to six lanes from Ben Hill Griffin Parkway to Fire House Lane, and to four lanes from Fire House Lane to Bella Terra Boulevard. The project includes adding on-road bike lanes, some sidewalk, installing new drainage, and constructing a wildlife crossing approximately 1000 feet west of the entrance to Cypress Shadows Boulevard. This crossing will coincide with a regional flow-way that crosses Corkscrew Road at that location. Once the project is completed, the Village of Estero will be installing shared use paths, lighting, and landscaping. Drivers, pedestrians, and bicyclists are urged to use extra caution when traveling through the work zone. Please be aware of shifts in travel lanes and bike lanes, sidewalk detours, miscellaneous turn lane closures, and uneven pavement throughout the project. Corkscrew motorists should expect slower than usual traffic when approaching The Preserve as work is occurring in the community's entrance.

The following work activities are scheduled to occur, however unforeseen underground conditions and weather may affect this schedule:

- This week crews continue concrete work in the Wildcat Run driveway. Access will be maintained.
- Crews continue **construction of the bridge/wildlife crossing** between Wild Blue Boulevard and The Preserve at Corkscrew that will allow animals to cross under Corkscrew Road, similar to the crossing just east of Alico Road. A 10-foot-high fence will be installed to funnel the wildlife to cross at this location. Currently crews are constructing box culverts near the bridge/crossing that convey water under the roadway, and forming the superstructure of the bridge. Motorists should be aware of vehicles entering/exiting the road in this area.
- Bicyclists should expect the bike lane from Stoneybrook Golf Drive to just east of Wildcat Run to be combined with the travel lane while crews work on the north side of the road.
- Pedestrians must use the temporary walkway on the south side of Corkscrew Road from Ben Hill Griffin Parkway to Stoneybrook Golf Drive.
- Currently in the area between Wild Blue Boulevard and Cypress Shadows Boulevard (The Preserve at Corkscrew) vehicles are using temporary lanes on the north side of the road to allow crews to work on the south side of Corkscrew Road.
- Turn lanes are currently unavailable at Wild Blue Boulevard, Cypress Shadows Boulevard (The Preserve at Corkscrew), Midnight Blue Boulevard, and Bella Terra Boulevard.
- WORK PERFORMED BY OTHERS: GL Homes is currently hauling material to their development site across from Wild Blue Boulevard. Motorists should expect delays and use caution as construction vehicles enter/exit the roadway. On heavy haul days, GL Homes will be providing flaggers to reduce backups on Corkscrew Road.

Crews are installing curb, drainage, and sod, as well as performing earthwork, and relocating utilities. MOTORISTS ARE REMINDED TO OBEY THE POSTED SPEED LIMIT. Please use caution and watch for workers and construction vehicles entering and leaving the roadway. **Estimated completion is late 2023**. Project cost is approximately \$23 M. US41/Cleveland Ave from Winkler Avenue to SR 82/Dr. Martin Luther King Jr. Boulevard: Construction project: Crews will be installing and relocating utilities and constructing medians on US 41/Cleveland Avenue from Winkler Avenue to SR 82.

- Expect Canal Street (both sides) closed at US 41/Cleveland Avenue.
- Expect Victoria Avenue closed on the east side of US 41/Cleveland Avenue.
- Expect Hopple Street closed on the east side of US 41/Cleveland Avenue.

Motorists should expect side road closures from Winkler Avenue to Victoria Avenue throughout the duration of the project. **Motorists should expect intermittent northbound and southbound**

lane closures and detours on US 41/Cleveland Avenue during daytime and nighttime/overnight hours Monday through Friday throughout the duration of the project.

Additional work includes installing drainage structures, pedestrian signals, upgrading signals and lighting, and resurfacing existing highway. The project will be constructed in three segments. Each segment will have most of the construction completed prior to moving to the next segment Construction will begin on the **first segment from Winkler Avenue to Carrell Road**. Crews will work on the west side of the road initially and when that work is completed, they will shift to the **east side of Cleveland Avenue/US 41.** The expected project completion is **Spring 2023.**

North Lee County Wellfield Expansion Phase IIIA Project – Fort Myers (ROW2022-00030). Nalle Grade Road between Slater Road to Nalle Road - RPU is installing a Raw Water Main and Fiber Optics Conduit via directional drill from February 28, 2022 through September 30, 2022. Directional Drill will be performed along Nalle Grade Road from Slater Road heading east towards Nalle Road. Eastbound lane along Nalle Grade Road from Slater Road to Nalle Road will be subject to temporary daily lane closures or permanent lane closures. Traffic will be maintained with either temporary traffic signals or flagmen depending on which MOT is used. Working hours shall be from 7:00 AM to 7:00 PM.

Lee County RWA –Crystal Drive (Plantation Road to US 41) Water Main Improvements (ROW 2022-00020): Beginning April 4, 2022, contractors for Lee County will install new water main beginning on the west side of Planation Road just south of the roundabout with Crystal Drive. Then install the water main on the south side of Crystal Drive from Plantation Road to US 41 to tie into a connection point on the east side of US 41 just south of Crystal Drive. Crews will also install water main from a connection point on the east side of US 41 near 12499 Cleveland Avenue (PDQ). Then continue east to Austin Street and west under US 41 to the north side of Brantley Road and tie into a connection point between Pine Grove and Brantley Pines driveways. Crews are expected to work 7:00 AM to 7:00 PM. This project is expected to be completed in summer 2023. Drivers, pedestrians and bicyclists should use caution and be aware of construction equipment and vehicles entering/exiting streets in the project area.

<u>Sidewalk and Driveway closure between 2278 Crystal Drive and 2442 Crystal Drive - Beginning 7:00 AM through 5:00 PM on Monday, August 22, 2022 through Friday, August 26, 2022, crews will close sidewalks and driveways for water main crossing.</u>

<u>Sidewalk closure at Crystal Drive and 12270 Metro Parkway -</u> Continued sidewalk closure approximately 10′, **August 22, 2022 through August 26, 2022**.

North Lee County Wellfield Expansion Phase IIIA Project – Fort Myers (ROW2022-00030). Nalle Road between Nalle Grade Road and Sedgefield Road - RPU is installing a Raw Water Main and Fiber Optics Conduit via directional drill from September 8, 2022 through November 30, 2022. Directional Drill will be performed along Nalle Grade from Nalle Grade Road heading south towards Sedgefield Road. SB lane will be permanently closed. NB lane will be open at all times. MOT will be set up to advise residents of the permanent SB lane closure. Working hours shall be from 7:00 AM to 7:00 PM.

Fiesta Village WWTP RM Upgrade – Fort Myers (ROW2022-00175): Accurate Drilling Systems, Inc. will be performing a horizontal direction drill along the north R/W line of Summerlin Avenue from east of Bass Road to west of Winkler Road **beginning Monday, May 9, 2022 and continue through Thursday, September 1, 2022.** Reclaimed water main installation will be performed.
