#### If you or any eligible family members get orthodontic care, this flyer can help you with:

## To get started, follow these two steps:

- 1. Tell your orthodontist you're now an Aetna Dental member.
- 2. Share this flyer during your next visit. It will help the office staff correctly fill out your first claim form. This will help us review your claim faster.

## Already have an orthodontic treatment plan?

- You probably have a pre-treatment quote that your prior dental plan approved. If you do, send it with a completed Aetna claim form to:

- As long as your treatment plan hasn't changed, no further clinical review is needed.
- We will:
  - > Let you know if your plan covers the care your dentist suggested.
  - > Send you a quote with what your plan will cover. Coverage may depend, in part, on whether dentist giving care is in our dental network.

### Submitting the first Aetna Dental claim

Your patient is now an Aetna Dental plan member. Please include all of the details below with your first paper or electronic claim.

The information will help us review the claim faster. It may also prevent the need for extra claims.

- Banding date
- Number of months of treatment
- Assignment information
- ADA code
- Total case fee
- Explanation of benefits from the primary insurance provider — if your patient has another dental plan
- Prior dental plan information if patient is currently in treatment; including deductible and coinsurance/copay amounts, plan maximum and amount paid to date
- Initial claim for the treatment plan
- Also, our enhanced claim system automatically sets up a regular payment schedule for most treatment plans.

\*Orthodontia is not covered under all dental plans. Please check your plan documents for details.
