REGULATORY STANDARDS



►The U.S. Department of Transportation (USDOT) requires recipients of federal financial assistance to maintain and update a Disadvantaged Business Enterprise (DBE) Program every three years.

► In compliance with 49 CFR part 26, LeeTran has reassessed its DBE goal for the upcoming FY 2025 – 2028. The methodology used to set this goal is presented in this presentation. Per 49 CFR Part 26, the public will have 45 days to provide comments on the proposed DBE goal and program.

DBE GOAL SETTING PROCESS



DBE Goal Setting Process







1. Base Figure

Determine % of DBE certified businesses in comparison to all other businesses in geographic market

2. Adjust Base

Examine evidence to determine if any adjustments should be made to the calculated base figure

3. Set Official Goal

Present official goal to public and allow 45 days for comment



DBE Goal Calculations

- A. Determine Project NAICS Codes
- B. Determine DBEs Available in Market Area
- C. Determine the Universe of Firms Available in Market Area

Weighing the "Base Figure" DBE Goal

Step 1: Determine the weight of each type of work by NAICS code category

- a. 2.7% of the work is in the Construction Services
- b. 97.3% of the work is in the Professional, Scientific, and Technical Services

Step 1: Determining the "Base Figure" DBE Goal

- Calculate percent availability
- NAICS Code 23 Availability =
- ► NAICS Code 23 Availability = 0.25787 X 100
- ► NAICS Code 23 Availability = .2579%

- DBEs Available in Market Area per CodeX 100All firms Available in Market Area per NAICS Code
- <u>9 X 100</u> 3.490

Step 3:Calculate Weighted Base Figure=Availability x Weight x 100Weighted Base Figure=0.00257880 x .27 x 100Weighted Base Figure=1.13%

◆ The adjusted goal is 0.6 percent. LeeTran believes a goal of 0.6 percent is achievable for the FY 2025-2028 timeframe.

Race/Gender-Neutral & Race/Gender Conscious Division of Goals

LeeTran estimates that the overall goal of .06 percent will be obtained from race-neutral participation and zero percent through race-conscious measures.

LeeTran uses the following race-neutral means to increase participation:

- Arrange solicitation opportunities to facilitate DBE and small business participation.
- Ensure distribution of the DBE directory to the widest group of potential prime contractors.
- Provide technical assistance and other services.
- > Carry out information and communication programs on contracting procedures and specific contract opportunities.
- Implement a supportive-services program to develop and improve immediate and long-term business management, which will be completed through coordination with FGCU Small Business Development Center.
- > Provide services to help DBEs and other small businesses, improve long-term development and achieve self-sufficiency.
- Establish a program to assist new, start-up firms, particularly in fields in which DBE participation has been historically low.
- Assist DBEs and other small businesses to develop their capability to utilize emerging technologies and conduct business through electronic media.
