Page 13 Item D of Contract 7806 states that price adjustments may be requested 30 days prior to the renewal date. Our contract will expire on September 4th of this year, so we would request that price increases be considered based upon changes in the Consumer Price Index.

The original bid date for B170265/ANB May 10, 2017. At that time the CPI was 244.733. As of the end of May the CPI is 251.588. This change of 6.855 in CPI results in a 2.8% increase. Attached is a chart of CPI values for your review. Cutler Repaving is requesting increases of 2.8% for the fifteen individual bid items.
