**TITLE:** Renew Contract for Minor Paving, Drainage & Concrete Improvements

### I. MOTION REQUESTED

A) Approve contract renewal under Solicitation No. B180007ANB, to provide for minor paving, drainage & concrete improvements Countywide, through 10/15/2020, in an amount not to exceed \$2,750,000.00, with Ajax Paving Industries of Florida, LLC; Bonness, Inc.; Boyd Irrigation, Inc.; Clary's Sitework & Developments, Inc.; Coastal Concrete Products, LLC dba Coastal Site Development; Community Asphalt, Corp.; Denco Construction, Inc.; JRL Underground Utilities, Inc.; Pavement Maintenance, LLC; Preferred Materials, Inc.; Southern Striping Solutions, LLC; Thompkins Contracting, Inc.; and Tomahawk Construction, LLC. Each project over \$100,000.00 will be taken to the Board for approval.

B) Grant the County Manager or designee the authority to execute any documents associated with the renewals on behalf of the Board of County Commissioners.

### II. ITEM SUMMARY

The proposed Board action renews contracts with the following vendors for minor paving, drainage and concrete improvements Countywide for an additional one-year term: Ajax Paving Industries of Florida, LLC; Bonness, Inc., Boyd Irrigation, Inc., Clary's Sitework & Developments, Inc., Coastal Concrete Products, LLC dba Coastal Site Development, Community Asphalt, Corp., Denco Construction, Inc., JRL Underground Utilities, Inc., Pavement Maintenance, LLC, Preferred Materials, Inc., Southern Striping Solutions, LLC, Thompkins Contracting, Inc., and Tomahawk Construction, LLC, through October 15, 2020, in an amount not to exceed \$2,750,000.00. Each project over \$100,000.00 will be taken to the Board for approval. This is the final renewal for this contract.

On October 18, 2018, the Board approved 14 contracts under the formal solicitation for the purchase of minor paving, drainage and concrete improvements Countywide for a term of one year, with the option to renew for one additional year. Ajax Paving Industries of Florida, LLC, Clary's Sitework & Development, Inc. and Denco Construction, Inc. have been issued CPAs in Fiscal Year 2018-2019, totaling \$1,104,078.36. This is the final renewal for this contract.
