TITLE: Award Contract for Apparel for Lee County - Countywide

I. MOTION REQUESTED

A) Award Invitation to Bid No. B210356MIF, Apparel for Lee County to 1 Touch Printing L.L.C., Matteo Graphics, Inc., Promotional Designs, Inc., and Westview Corp., Inc. for the supplying of silk screen services, embroidery services and apparel, on an as needed basis, for an initial term of three years, as approved in the departments' annual adopted budget. Individual purchases in excess of \$100,000.00 will be presented to the Board for approval.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contracts, for up to three years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewals.

II. ITEM SUMMARY

Awards competitively solicited contracts to 1 Touch Printing L.L.C., Matteo Graphics, Inc., Promotional Designs, Inc., and Westview Corp., Inc. for the supply of silk screen services, embroidery services and apparel, on an as-needed basis for an initial term of three years, as approved in the departments' annual adopted budgets. The contract can be renewed up to three additional years, upon the agreement of all parties. Total expenditures for these services for Fiscal Year 21-22 were \$206,513.22. Procurement Management received five bids and awarded contracts to four vendors, to be used in the manner that meets the needs of the department and Lee County. Individual purchases in excess of \$100,000.00 will be presented to the Board for approval.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

Procurement Management obtained bids for the project known as Invitation to Bid No. B210356MIF, Apparel for Lee County. On the bid deadline of December 1, 2021, Procurement Management received 5 submittals. After conducting an analysis of the bid submissions, 1 Touch Printing L.L.C., Matteo Graphics, Inc., Promotional Designs, Inc., and Westview Corp., Inc. were determined to be the responsible bidders with responsive bids.

Staff recommends awarding contracts to 1 Touch Printing L.L.C., Matteo Graphics, Inc., Promotional Designs, Inc., and Westview Corp., Inc for use on an as-needed basis for an initial term of three years, as approved in the departments' annual adopted budget. The contract can be renewed for an additional three years, upon the agreement of all parties. Expenditures to date during Fiscal Year 21-22 were approximately \$206,513.22.
