TITLE: Award Contract for Athletic Turf Maintenance and Field Reconstruction

#### I. MOTION REQUESTED

A) Award Invitation to Bid No. B230548WCD for Athletic Turf Maintenance and Reconstruction to JSM Services, Inc., for Parks and Recreation on an as needed basis, for an initial term of three years, as approved in the department's annual adopted budget. Individual purchases in excess of \$100,000.00 will be presented to the Board for approval.

- B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C) Grant the County Manager or designee the authority to renew the contract upon mutual written agreement of both parties, the parties may renew the Agreement, in whole or in part, for a renewal term not to exceed two years. The increments of the renewal shall be at the sole discretion of the County as deemed in its best interest, and to execute all associated documents, as approved by the department's annual adopted budgets, if doing so is in the best interest of Lee County and, there are no cost increases associated with the renewal(s).
- D) Authorize the Director of Procurement Management to add or delete work, services and/or locations as needed and to execute any documents necessary for these changes.

#### II. ITEM SUMMARY

Awards a competitively bid contract to JSM Services, Inc. to provide labor and materials to complete athletic turf maintenance and reconstruction. Services will be provided on an as-needed basis for a period of three years. The contract includes an option to renew the agreement, in whole or in part, for a renewal term, or terms, not to exceed two years, as approved in the department's annual adopted budget. Total expenditures for these services FY19 through FY23 were \$6,820,362.16. Projects are funded through the department's operating budgets.

# III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On Oct 6, 2023, Procurement Management advertised B230548WCD, Athletic Turf Maintenance and Reconstruction for various athletic fields throughout Lee County on behalf of the Board of County Commissioners. On the bid deadline of November 8, 2023, Procurement Management received one bid submission. Based on the bid submission pricing, it is recommended the award is given to JSM Services, Inc.
