WHEREAS, after execution of the Agreement, DTC Distributors, LLC changed their business name to Distributor Operations, Inc. dba IBS Southwestern Florida with a Federal Tax ID Number of 75-1864347; and,

WHEREAS, County and Vendor desire to enter into this First Amendment to continue their Agreement via Solicitation No. B200180MIF under the Vendor's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, conducting business as Distributor Operations, Inc. dba IBS Southwestern Florida, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. B200180MIF, including appendices and amendments, and Vendor's response.

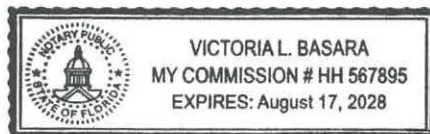
