## THIRD AMENDMENT OF THE AGREEMENT FOR LEE COUNTY DOT ROADWAY LIGHTING

THIS THIRD AMENDMENT OF THE AGREEMENT FOR LEE COUNTY DOT ROADWAY LIGHTING is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Consolidated Electrical Distributors, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase LED roadway lighting fixtures, through Solicitation No. B200271MIF, with Vendor on the 16<sup>th</sup> day of October, 2020 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for the purchase of LED roadway lighting fixtures from the Vendor, add additional products required by Lee County's Department of Transportation, and update the part number for many of the products listed; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 6<sup>th</sup> day of October 2025; and,

WHEREAS, pursuant to Article XV. Miscellaneous of the Agreement, the Parties desire to modify the Exhibit B, Fee Schedule, of the Agreement to increase the price for the purchase of LED roadway lighting fixtures, add items 36 through 39, and update the part numbers accordingly.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

The Parties agree that, effective October 6, 2025, the Fee Schedule in Exhibit B of the Agreement shall be superseded by the following:
