

FIRST AMENDMENT OF AGREEMENT FOR
TEMPORARY PERSONNEL SERVICES

THIS FIRST AMENDMENT OF THE AGREEMENT FOR TEMPORARY PERSONNEL SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Alpha Staffing/Search Firm LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of temporary personnel services on an as needed basis through Solicitation B170107LKD with Vendor on the 13th day of June, 2017 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the hourly rates for the personnel available from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 13th day of June, 2019; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XIV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:
