

SECOND AMENDMENT OF ANNUAL AGREEMENT  
FOR EQUIPMENT RENTAL

THIS SECOND AMENDMENT OF THE ANNUAL AGREEMENT FOR EQUIPMENT RENTAL made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Creel Tractor Rental LLC. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of the rental of power and non-power equipment through Solicitation B170516RJD with Vendor on the 28<sup>th</sup> day of June, 2018 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the rate for the rental of power and non-power equipment from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 28<sup>th</sup> day of June, 2021; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:




