

FIRST AMENDMENT OF AGREEMENT FOR CORROSION/SCALE
INHIBITOR FOR UTILITIES WATER TREATMENT PLANTS

THIS FIRST AMENDMENT OF THE AGREEMENT FOR CORROSION/SCALE INHIBITOR FOR UTILITIES WATER TREATMENT PLANTS, is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the state of Florida, hereinafter referred to as the "County," and Amaya Solutions, Inc., dba American Water Chemicals, hereinafter referred to as the "Vendor."

WHEREAS, the County entered into an Agreement for Corrosion/Scale Inhibitor for Utilities Water Treatment Plants, through Solicitation Number B180012LKD, with Vendor on the 12th day of April, 2018 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Vendor's business entity name was American Water Chemicals Inc. with a Federal Tax ID Number of 95-4412808; and,

WHEREAS, County was advised by Vendor in October 2020 that American Water Chemicals Inc. had been acquired by a parent company, Amaya Solutions, Inc., but will continue doing business as Amaya Solutions, Inc. dba American Water Chemicals, with a Federal Tax ID Number of 84-4097612; and,

WHEREAS, pursuant to Section XV. MISCELLANEOUS of the Agreement, County and Vendor desire to enter into this First Amendment to continue their Agreement via Solicitation No. B180012LKD under the Vendor's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, conducting business as Amaya Solutions, Inc. dba American Water Chemicals, shall continue to supply such commodity or service in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. B180012LKD, including appendices and amendments, and Vendor's response.
