

SECOND AMENDMENT OF THE ANNUAL AGREEMENT
FOR SODIUM BISULFITE 40% AQUEOUS SOLUTION

THIS SECOND AMENDMENT OF THE ANNUAL AGREEMENT FOR SODIUM BISULFITE 40% AQUEOUS SOLUTION is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the state of Florida, hereinafter referred to as the "County," and Thatcher Chemical of Florida, Inc., hereinafter referred to as the "Vendor."

WHEREAS, the County entered into an annual Agreement for the purchase of Sodium Bisulfite 40% Aqueous Solution through Solicitation Number B180243RJD with Vendor on the 31st day of August, 2018 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for the purchase of Sodium Bisulfite 40% Aqueous Solution from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 13th day of November, 2021; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:
