It was a pleasure to talk with you last week. Thank you for listening to my concerns regarding the procurement of independent contractor, NCAA registered softball umpires for the immediate future of 2022 and beyond. I am writing to recap our agreement and the proposal to extend the contracted services of Naples Referee and Umpire Association for an additional *two* years as follows and with the additional amended terms;

- Bat testing is now a requirement of the NCAA. To meet the requirement two UIC's will need to be present to expedite team entry at various times during the three week tournament. The process and time of service has and will always be determined by the Lee County site coordinator and discussion has been to provide two persons. No additional per hour compensation is requested for the hourly duties of UIC per contract and that only a second UIC be paid for by the County when requested in writing or verbally.
- Contract year. 11/20/2021 11/19/2022 the umpire game fee will increase to \$80 per game.
- Contract year. 11/20/2022 11/19/2023 the umpire game fee will increase to \$85 per game.
