

FIRST AMENDMENT OF THE AGREEMENT FOR PAINT  
AND PAINT RELATED PRODUCTS

THIS FIRST AMENDMENT OF THE AGREEMENT FOR PAINT AND PAINT RELATED PRODUCTS, is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and The Sherwin-Williams Company ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase paint and paint related products through Solicitation No. B180363JJB with Vendor on the 8<sup>th</sup> day of January, 2019 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that it would be in the best interests of the County for additional automotive-related product pricing to be added to the Exhibit B Fee Schedule; and,

WHEREAS, the Parties desire to modify the Exhibit B Fee Schedule of the Agreement pursuant to Article XV. Miscellaneous of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

The Parties agree that the following terms are added to the pricing table included in the Exhibit B Fee Schedule:

Automotive Paint	Less 35% Discount
Automotive Sundries	Less 30% Discount
Automotive Specialty Paint/Epoxy	Less 35% Discount
Automotive Delivery Charge	\$0.00
Automotive product pickup will be from the Fort Myers automotive branch located at Sherwin-Williams store #9214, 13081 Metro Pkwy Suite 2, Fort Myers, FL 33966.
