FIRST AMENDMENT OF THE AGREEMENT FOR MOWING AND LANDSCAPE MAINTENANCE FOR LEE COUNTY LIBRARIES

THIS FIRST AMENDMENT OF THE AGREEMENT FOR MOWING AND LANDSCAPE MAINTENANCE FOR LEE COUNTY LIBRARIES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and P&T Lawn & Tractor Service, Inc ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of mowing and landscaping services for Lee County Libraries through Solicitation No. B180368KLC with Vendor on the 12th day of October 2018 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that it would be in the best interest of the County to verify that the Vendor is complying with statutory background screening requirements; and,

WHEREAS, pursuant to Article XVI. Miscellaneous of the Agreement, the Parties desire to modify Article VIII. Responsibilities of the Vendor to require the Vendor to execute the Vendor Background Screening Affidavit.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

- 1. The Parties agree that the Article VIII. Responsibilities of the Vendor shall be supplemented by:
 - "F. The Vendor shall comply with the Vendor Background Screening Affidavit attached hereto and incorporated herein as Exhibit D."
- 2. The Parties agree that Exhibit D below shall supplement the Agreement and be added as "Exhibit D Vendor Background Screening Affidavit."

VENDOR BACKGROUND SCREENING AFFIDAVIT
