SECOND AMENDMENT OF THE AGREEMENT FOR B180400GWT ANNUAL PLUMBING SUPPLIES PROJECT

THIS SECOND AMENDMENT OF THE AGREEMENT FOR B180400GWT ANNUAL PLUMBING SUPPLIES PROJECT is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Ferguson Enterprises, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase plumbing supplies, through Solicitation No. B180400GWT, with Vendor on the 1st day of November, 2018 ("Agreement"); and,

WHEREAS, the Agreement was amended on the 17th day of May, 2019, to incorporate additional pricing discounts for specific plumbing supplies from new manufacturers not included on the original solicitation ("Amendment"); and,

WHEREAS, it was discovered after the execution of the Amendment that an error occurred and the Amendment failed to incorporate the blanket pricing discounts for specific plumbing supplies not included on the amended Exhibit B, Fee Schedule; and,

WHEREAS, the Parties desire to apply the blanket discount percentage to specific plumbing supplies not included on the amended Exhibit B, Fee Schedule; and,

WHEREAS, pursuant to Article XVI. Miscellaneous of the Agreement, the Parties desire to modify the Exhibit B, Fee Schedule, of the Agreement to perform the aforementioned changes.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

The Parties agree that the Fee Schedule in Exhibit B of the Agreement and the Fee Schedule in the Amendment shall be superseded by the following revised fee schedule:
