

SECOND AMENDMENT OF AGREEMENT FOR
MISCELLANEOUS CHEMICALS FOR THE WATER AND WASTEWATER
TREATMENT PLANTS – ANNUAL

THIS SECOND AMENDMENT OF THE AGREEMENT FOR MISCELLANEOUS CHEMICALS FOR THE WATER AND WASTEWATER TREATMENT PLANTS - ANNUAL, is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the state of Florida, hereinafter referred to as the “County,” and American Water Chemicals Inc., hereinafter referred to as the “Vendor.”

WHEREAS, the County entered into an Agreement for Miscellaneous Chemicals for the Water and Wastewater Treatment Plants, through Solicitation Number B180434BAW, with Vendor on the 11th day of April, 2019 (“Agreement”); and,

WHEREAS, it was discovered after the execution of the Agreement that it would be in the best interests of the County to supplement the Exhibit C, Fee Schedule, to clarify the product delivery type for specific chemicals being provided by the Vendor; and,

WHEREAS, the Parties desire to modify the fee schedule’s delivery types to charge per pound for the chemicals, instead of per gallon, as originally bid; and,

WHEREAS, pursuant to Article XVI. Miscellaneous of the Agreement, the Parties desire to modify the Exhibit C, Fee Schedule, of the Agreement to perform the aforementioned changes.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:


The Parties agree that the Fee Schedule in Exhibit C of the Agreement shall be superseded by the following revised fee schedule:

Material	Product Delivery Type	Cost Per
Zinc Ortho-Phosphate - Bulk	1 lbs.	\$0.65
Zinc Ortho-Phosphate – 230/250 Gallon tote	1 lbs.	\$0.56




