On the bidding deadline of December 28, 2018, Procurement Management received two submittals. After conducting an analysis on the bid submissions, staff recommends making an award to Galls, LLC, the responsible bidder with the lowest responsive bid meeting all specification requirements.

These uniform items are budgeted annually within the Public Safety operation budget. Total expenditures for these goods during Fiscal Year 2017-2018 were approximately \$94,122.00.
