TITLE: Award Contracts for Welding and Fabrication Services - Countywide

I. MOTION REQUESTED

A) Award Invitation to Bid No. B180584JJB, Welding and Fabrication Services - Annual, to: Advanced Precision Machine of U.S., LLC; Titan MFG., Inc. and Daniel R. Mattos - Marine Engine Surveyor, Inc. dba M & M Machine, the responsible bidders with the lowest responsive bids, for an initial period of one year, as approved in the departments' annual adopted budgets.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to negotiate renewals of the contracts, including changes in price, for up to three additional one-year periods, and/or to extend the contracts up to six months, and to execute all associated documents, with County Administration approval, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Awards contracts to Advanced Precision Machine of U.S., LLC, Titan MFG., Inc. and Daniel R. Mattos - Marine Engine Surveyor, Inc. dba M & M Machine, to provide welding and fabrication services, for an initial period of one year with the option to renew for three additional one-year periods. Total expenditures for these services during Fiscal Year 2017-2018 were approximately \$382,533.47.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On November 20, 2018, Procurement Management advertised Invitation to Bid No. B180584JJB, Welding and Fabrication Services – Annual, on behalf of the Board of County Commissioners. On the bidding deadline of January 7, 2019, Procurement Management received three bids. After conducting an analysis on the bid submissions, staff recommends awarding contracts to Advanced Precision Machine of U.S., LLC, Titan MFG., Inc. and Daniel R. Mattos - Marine Engine Surveyor, Inc. dba M & M Machine as the lowest responsive, responsible bidders meeting all specification requirements.

Total expenditures for these services during Fiscal Year 2017-2018 were approximately \$382,533.47.
