## FIRST AMENDMENT OF THE ANNUAL AGREEMENT FOR LOT MOWING FOR CODE ENFORCEMENT

THIS FIRST AMENDMENT OF THE ANNUAL AGREEMENT FOR LOT MOWING FOR CODE ENFORCEMENT is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the state of Florida, hereinafter referred to as the "County," and Armata Lawn Care, Inc., hereinafter referred to as the "Vendor."

WHEREAS, the County entered into an annual Agreement for the purchase of lot mowing services through Solicitation Number B190004KLC with Vendor beginning on the 17<sup>th</sup> day of September, 2019 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for the purchase of lot mowing services from the Vendor; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XIV. MISCELLANEOUS of the Agreement.

1. The Parties agree that the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:
